By Procedural Order dated January 19, 2011, oral argument was set in this matter for February 22, 2011.


On February 10, 2011, the Arizona Corporation Commission ("Commission") Utilities Division ("Staff"), joined by Qwest Corporation ("Qwest"), filed an "Unopposed Joint Motion of Commission Staff and Qwest Corporation to Continue Hearing." The joint movants seek a continuance in this matter of approximately two months, in order to give Qwest, Pac-West Telecomm and Level 3, an opportunity to engage in settlement discussions under the provisions of Section 41 of the Settlement Agreement that has been filed in the Qwest/CenturyLink, Inc. merger docket (Docket No. T-01051B-10-0194). The joint movants state that they are authorized to report that Pac-West

1 and Level 3 do not oppose the continuance.

2 IT IS THEREFORE ORDERED that the **February 22, 2011 Procedural Conference for the**
3 **purpose of oral argument is continued until April 20, 2011, at 10:00 a.m.**¹, or as soon thereafter
4 as is practical, at the Commission's **Tucson office, Room 222**, 400 West Congress St., Tucson,
5 Arizona 85701.

6 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
7 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


