PROCEDURAL ORDER

BY THE COMMISSION:

On February 4, 2011, Far West Water & Sewer Company (“Far West” or “Company”) participated in an informational meeting attended by the Arizona Corporation Commission (“Commission”) Utilities Division Staff (“Staff”), the Residential Utilities Consumer Office (“RUCO”) and individual intervenors: Mr. and Mrs. Gilkey and Mr. Rist.


On February 8, 2011, Far West filed a Status Report addressing the Company’s dealings with the Arizona Department of Environmental Quality; its plan to raise additional capital; and the status of the plant upgrades, among other issues.

Consequently, another Procedural Conference for the purpose of discussing the various parties’ recommendations for further action in this docket is warranted.

IT IS THEREFORE ORDERED that a **Procedural Conference** to discuss the status of this docket and recommendations for future action shall commence on **March 23, 2011 at 10:00 a.m.**, or as soon thereafter as is practical, at the Commission’s **Tucson offices, Room 222**, 400 W. Congress St., Tucson, Arizona 85701. **Telephonic participation is permitted if the parties contact the Hearing Division at (602) 542-4251 to obtain the procedures, however, unless one of the parties can arrange a conference call number, telephonic participation may be limited to five connections.**


