The fourth in a series of workshops to comply with the investigation ordered in Decision No. 71878 will be held on Friday, March 25, 2011, at 10:00 a.m., in the Arizona Corporation Commission ("Commission") Hearing Room, 1200 West Washington Street in Phoenix.

Decision No. 71878 orders stakeholders, including the Commission Staff ("Staff") and Global Utilities, to commence a generic investigation which looks at how best to achieve the Commission's objectives with regard to encouraging the acquisition of troubled water companies and the development of regional infrastructure where appropriate.

Additionally, at a recent Commission Staff Open Meeting, the Commission agreed that these workshops should also examine the merits of imputing income tax expenses to S-corporations and to limited liability companies that have not elected to be taxed as C-corporations. This tax imputation issue will be the subject of discussion at this fourth Workshop. An agenda for the Workshop is attached.

Staff encourages all interested parties to submit written comments, preferably, prior to commencement of the Workshop. If advance submission of comments is not possible, parties are welcome to bring written comments with them to the workshop on March 25, 2011. Staff also invites any parties interested in making a brief presentation at the Workshop to submit a proposal by March 22, including a description/outline along with an estimate of the presentation time. Please file an original and 13 copies of your comments or proposal with the Commission's Docket Control Center, 1200 West Washington Street, Phoenix, Arizona 85007. All filings should reference Docket No. W-00000C-06-0149. Presentations requiring use of Commission equipment must be coordinated in advance with Commission Business Office personnel by contacting the individuals below.
