PROCEDURAL ORDER
(Schedules Procedural Conference)

BY THE COMMISSION:

On June 1, 2010, Cerbat Water Company ("Company" or "Applicant") filed with the Arizona Corporation Commission ("Commission") an application for approval of a permanent rate increase ("Application").

On July 1, 2010, the Commission's Utilities Division ("Staff") issued a Notice of Insufficiency pursuant to A.A.C. R14-2-103(B).

On November 17, 2010, Staff issued a Notice of Sufficiency on the Application by the Company and classified the Company as a Class "D" water utility.

On February 4, 2011, Staff filed it report recommending that Staff's proposed rates and charges be approved by the Commission.

On February 22, 2011, the Company filed Comments to the Staff Report and took issue with the recommendations which had been made by Staff.

Under the circumstances, it will be necessary for a procedural conference be held to address the issues raised by the Company with Staff's recommendations.

IT IS THEREFORE ORDERED that a **procedural conference** shall be held on **March 21, 2011, at 2:00 p.m.**, at the Commission's offices, 1200 West Washington Street, **Hearing Room No. 1**, Phoenix, Arizona.

IT IS FURTHER ORDERED that the time frame in this proceeding shall be suspended until further order pursuant to A.A.C. R14-2-103.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance

1 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the
2 Rules of the Arizona Supreme Court). Representation before the Commission includes appearances
3 at all hearings and procedural conferences, as well as all Open Meetings for which the matter is
4 scheduled for discussion, unless counsel has previously been granted permission to withdraw by the
5 Administrative Law Judge or the Commission.

6 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
7 Communications) applies to this proceeding and shall remain in effect until the Commission's
8 Decision in this matter is final and non-appealable.

9 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
10 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
11 hearing.
