

On (January 24, 2011), Aztech Communications, LLC ("Company") filed an application ("Application") with the Arizona Corporation Commission ("Commission") to cancel the Company's Certificate of Convenience and Necessity for local and long-distance telecommunications services. If approved by the Commission, the Company will no longer provide local and long distance telecommunications service to customers in Arizona. The Application, report of the Commission's Utilities Division Staff, and any exceptions to the Staff report prepared by the Company are available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007 and at the office of the Company's Regulatory Consultant regarding the Application, (Mr. Alonzo Beyene of Industry Assurance Consulting, Inc. - 6303 Blue Lagoon Drive, Suite 400, Miami, Florida 33126). Pursuant to A.C.C. R14-2-1107(B), interested persons shall have thirty (30) days from the publication of this notice to file objections to the Application, to request a hearing, and to submit a motion to intervene. The granting of motions to intervene shall be governed by A.A.C. R14-3-105. The granting of Interventions, among other things, entitles a party to present sworn evidence at a hearing and to cross-examine other witnesses. If no objection to the Application is made, the Commission may grant the Application without a hearing.
