**NOTICE OF RESOLUTION
REGARDING SUFFICIENCY AND
WITHDRAWAL OF MOTION
REGARDING SUFFICIENCY OF
RATE APPLICATIONS**

On December 29, 2010, the East Slope Water Company, Antelope Run Water Company and Indiada Water Company (“Companies”) filed Motions Regarding Sufficiency of Rate Applications seeking to have the Companies’ rate applications deemed sufficient in all pertinent dockets. Pursuant to the Court’s instructions during the procedural conference hearing on February 11, 2011, the Companies and Staff discussed the sufficiency issues raised by the Companies and resolved the controversy as follows:

- Staff will find the applications sufficient;
- All four rate cases and the finance case will be consolidated upon motion of either Staff or the Companies;
- Staff and the Companies will continue to work in good faith to address the issues listed by Staff in the insufficiency letters.

Now that the sufficiency issues are resolved, the Companies' motion is moot, and therefore, the Company withdraws the motion.

Alternatively, if the Court determines that procedurally the Companies must move to withdraw the motion, then Companies request that the Court treat this pleading as a motion for withdrawal based upon the affirmations presented herein. The Companies further move the Court to find the motions moot with no further action by either the Court or parties.
