

23 On February 28, 2011, the Arizona Corporation Commission Staff ("Staff") filed  
 24 a Request for a Procedural Schedule ("Request") in this matter. On March 3, 2011, the  
 25 Residential Utility Consumer Office ("RUCO") joined that Request, with one proposed  
 26 modification. Arizona Public Service Company ("APS") has since consulted with both  
 27 Staff and RUCO, and hereby proposes the following alternative dates, with which Staff  
 28 and RUCO agree:

- Staff and Intervenor Direct Testimony – Due Tuesday, May 31, 2011;
- Applicant's Rebuttal Testimony – Due Wednesday, June 22, 2011; and
