TO WITHDRAW FRANCISCO
GRANDE APPLICATION**

14 The Utilities Division (“Staff”) of the Arizona Corporation Commission files its response to
15 the motion by Global Water - Palo Verde Utilities Company (“Palo Verde”), Global Water - Santa
16 Cruz Water Company (“Santa Cruz”) and CP Water Company (collectively, the “Global Utilities”) to
17 withdraw the application for the transfer of assets and the certificate of convenience and necessity of
18 Francisco Grande Utility Company (“Francisco Grande”).

19 While the Global Utilities do not own Francisco Grande and cannot request on Francisco
20 Grande’s behalf, the Global Utilities, as co-applicants, have standing to request the withdrawal of the
21 application. Staff has no objection to the Global Utilities motion to withdraw.

22 With respect to Francisco Grande’s motion for an extension of time, because the matter was
23 not set for the March 1 and March 2, 2011 Open Meeting, the request is moot and does not require a
24 response from Staff.
