Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On November 1, 2010, the Commission issued Decision No. 71956 which authorized rates and charges for Coronado Utilities, Inc.'s ("Coronado" or "Company") provision of wastewater utility service.
2. Decision No. 71956 did not include Service Line Installation Charges.
3. On January 12, 2011, Coronado filed a Motion for Order *Nunc Pro Tunc* to correct Decision No. 71956 to include the approval of service line installation charges.¹
4. Service Line Installation Charges for Coronado were initially approved in Decision No. 68608 (March 23, 2006).
5. In its most recent application for new rates and charges, Docket No. SW-04305A-09-

1 0291, Coronado requested that the Service Line installation Charges remain unchanged. The
2 Commission's Utilities Division Staff did not oppose the proposed Service Line Installation Charges.

3 6. The omission of the approval of Service Line Installation Charges in Decision No.
4 71956 was inadvertent.

5 7. Accordingly, the inadvertent omission on page 20 of Decision No. 71956 should be
6 corrected to include the requested Service Line Installation Charges.

7 **CONCLUSIONS OF LAW**

8 1. Coronado is a public service corporation within the meaning of Article XV of the
9 Arizona Constitution and A.R.S. §§40-250, 40-251, 40-367 and 40-361.

10 2. The Commission has jurisdiction over Coronado and the subject matter contained in the
11 Company's rate application.

12 3. Good cause exists to modify Decision No. 71956 to correct the inadvertent omission of
13 Service Line Installation Charges.

14 4. Notice of the proceeding was provided in conformance with law.

15 5. The rates, charges and conditions of service established in Decision No. 71956, as
16 modified herein, are just and reasonable and in the public interest.

18 **ORDER**

19 IT IS THEREFORE ORDERED that Decision No. 71956 is hereby modified, *nunc pro tunc*,
20 as follows:
