PROCEDURAL ORDER

**BY THE COMMISSION:**

On March 1, 2011, counsel for Goodman Water Company ("GWC" "Company") filed a Notice of Transmittal of Documents to Assigned Administrative Law Judge for *In Camera* Review. By separate letter of the same date, GWC mailed copies of the GWC minutes of shareholders' meetings to the Administrative Law Judge. In the Notice, GWC states that the individual Intervenors requested the shareholders' minutes in their Data Request 2.14. Neither the relevancy of the data request, nor the basis of the objection, is clear from the filing.

To assist the Administrative Law Judge in her review of the minutes, the Company shall file a copy of the Intervenors' Data Requests 2.17 and 3.05, and the Company's responses thereto. In addition, a telephonic procedural conference will be set to discuss the intervenors' requested discovery and the bases for the Company's objection(s) thereto.


IT IS THEREFORE ORDERED that a **Telephonic Procedural Conference** shall commence on **March 23, 2011, at 1:30 p.m.**, or as soon thereafter as is practical **at the Commission's Tucson offices, Room 218, 400 West Congress, Tucson , Arizona 85701.**

IT IS FURHTER ORDERED that GWC shall file a copy of the relevant Data Requests and the Company's responses thereto as soon as practical and prior to the Procedural Conference.

1 IT IS FURTHER ORDERED that the parties shall **contact the Hearing Division (602) 542-**  
2 **4250** to obtain procedures for the telephonic Procedural Conference.

3 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
4 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
