Page 26, Lines 10 to 11:

DELETE:

“Thus, we will require Rigby immediately to refund to Dains the amount of \$209,727.25, without interest,³⁴ as required under Rule 406(M).”

INSERT:

“Thus, we find that the amount of \$209,727.25, without interest,³⁴ is immediately due and payable to Dains, as required by Rule 406(M), and we will require Rigby to pay this amount to Dains as provided below.”

Page 27, Line 14:

DELETE:

“Under A.A.C. R14-2-406(M), Rigby must immediately pay Dains \$209,727.25.”

INSERT:

“Under A.A.C. R14-2-406(M), the amount of \$209,727.25 is immediately due and payable to Dains.”

Page 27, Lines 16 through 18:

DELETE: existing ordering paragraph

INSERT: three new ordering paragraphs as follows:

“IT IS FURTHER ORDERED that the amount of \$209,727.25 is immediately due and payable to the Estate of Charles J. Dains.


