The Respondent, Wayne Scott Clague hereby requests that the case #S-20759A-10-0387, and the Decision # 72205 be set aside in favor of a rehearing.

In June Of 2008, the respondent Wayne Scott Clague filed a complaint with the Attorney

1 General's consumer Protection division. The undersigned received a notice from Investigator Clyde
2 J. Hanselman. An appointment was made and the undersigned went to the offices located on 1220
3 West Washington St, Phoenix AZ. During this meeting the undersigned presented copies of LLC
4 documents, operating agreements and bank records to Mr. Hanselman. Mr. Hanselman told the
5 undersigned that he would look into the case. This process took several months until the undersigned
6 received a call asking him to confirm last known address for Nathan Nordstrom and places of
7 business. Mr. Hanselman told the undersigned that the Attorney General's Office was reviewing the
8 complaint and that if charges were to be filed, he would let the undersigned know.



10 In Sept 2010 the undersigned received a call from Mr. Hanselman enquiring as to his address as the
11 undersigned had moved. Mr. Hanselman stated that he needs the undersigned to sign a document and
12 that a case had been file against Mr. Nordstrom. The undersigned gave Mr. Hanselman the new
13 address and Mr. Hanselman came to the undersigned's new residence. Mr. Hanselman asked the
14 undersigned to sign for a document and upon reading it the undersigned then asked of Mr.
15 Hanselman why his [Clague] name was listed as a respondent. Mr. Hanselman told the undersigned
16 that he was a member of LLC therefore all members were listed.

19 The undersigned was given the impression that he would be identified as the person who presented
20 the evidence for the case against Mr. Nordstrom and that their case was directed at Mr. Nordstrom.

21 Over the next several weeks and months the undersigned received copies of the proceedings. Upon
22 reading the decision dated Dec 10 2010, the undersigned was under the belief that the Corporation
23 Commission had indeed found that Mr. Nordstrom had conducted improper dealing relating to
24 investors within Norstreet Portfolio, LLC and subject to fines accordingly. The undersigned did not
25 see my name [Clague] associated with the findings and thus considered the case closed. The

1 undersigned, then Feb 2011 received a notice to Order to Cease and Desist and order to Dismiss with
2 Clague's and Clague's ex-wife's names on said document. The undersigned thought this was the
3 final step releasing us from this case.
4 On March 3, 2011 the undersigned received the decision ruling dismissing Clague's ex-wife,
5 however naming Clague as responsible for all the same action taken against Mr. Nordstrom.

7 The undersigned was completely taken by surprise by this ruling and therefore the undersigned is
8 requesting a rehearing of the case to clear his name. The Respondent Wayne Scott Clague is
9 requesting respectfully an appeal of the decision rendered on March 3 2011 and requesting the
10 opportunity appear and clear up the facts relating to this matter.
