**STAFF'S REPLY TO UNION PACIFIC
RAILROAD COMPANY'S MOTION
FOR MODIFICATION OF PROCEDURAL
ORDER DATED FEBRUARY 17, 2011**

On March 22, 2011, counsel for Union Pacific Railroad Company ("Company") filed a motion requesting various modifications to the procedural order dated February 17, 2011. Generally, the requested modifications related to times for compliance with notice provisions set out in the procedural order. The first related to providing copies of the application to various parties by mail and the second related to public notice by publication in a newspaper. In its motion, the Company related that it has provided the required mailings. Likewise, it stated that it was in the process of performing the public notice by publication in a newspaper which would be complete by March 28, 2011.

Staff believes that the mailing to parties satisfies the required mailing of the application and procedural order to parties. Additionally, Staff notes that the public notice being performed by the Company will be complete well in advance of the scheduled May 5, 2011 hearing date. As such, Staff believes that the publication effort undertaken by the Company is appropriate and Staff has no objection to the proposed modification to the procedural order.
