21 (Superior Court of Arizona in and for Mohave County, Case No. CV2009-02574).


22 Complainants' case in Superior Court is still pending and the parties are still conducting  
23 discovery. On or about December 10, 2010, the Superior Court ordered the parties to submit a  
24 joint pre-trial memorandum and proposed scheduling order relating to discovery and disclosure  
25 deadlines by March 14, 2011. The parties agreed upon various scheduling dates and timely  
26 submitted a Joint Scheduling Memorandum pursuant to the Court's order.
