**SECOND  
PROCEDURAL ORDER**  
**(Schedules Status Conference)**

**BY THE COMMISSION:**

On February 2, 2011, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Jerry Martin Tolle, Sr. and Jane Doe Tolle, husband and wife, Cashflow Investment Properties, LLC ("CIP"), an Arizona limited liability company, and Jason Mendoza and Jane Doe Mendoza, husband and wife, (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts. Respondent spouses, Jane Doe Tolle and Jane Doe Mendoza, were joined in the action for the purposes of determining the liability of their respective marital communities.

The Respondents were duly served with a copy of the Notice.

On February 16, 2011, Respondent, Jason Mendoza, filed a request for hearing in this matter.

On February 24, 2011, by Procedural Order, a pre-hearing conference was scheduled on March 21, 2011

On March 21, 2011, at the pre-hearing conference, the Division appeared with counsel. Respondent Jason Mendoza appeared on his own behalf. Respondent Jerry Tolle also appeared on

1 his own behalf. The parties indicated they will be discussing the issues involved in the proceeding,  
2 and the Division requested that a status conference be scheduled in approximately 45 days.  
3 Subsequently, Respondent Jerry Tolle filed requests for hearing on behalf of himself and CIP.

4 Accordingly, a status conference should be scheduled.

5 IT IS THEREFORE ORDERED a **status conference** shall be held on **May 9, 2011, at 10:00**  
6 **a.m.**, at the Commission's offices, 1200 West Washington Street, 2<sup>nd</sup> Floor Conference Room,  
7 Phoenix, Arizona.


8 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized  
9 Communications) is in effect and shall remain in effect until the Commission's Decision in this  
10 matter is final and non-appealable.

11 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules  
12 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to the practice of law and admission  
13 *pro hac vice*.

14 IT IS FURTHER ORDERED that withdrawal or representation must be made in compliance  
15 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the  
16 Rules of the Arizona Supreme Court). Representation before the Commission includes appearances  
17 at all hearings and procedural conferences, as well as all Open Meetings for which the matter is  
18 scheduled for discussion, unless counsel has previously been granted permission to withdraw by the  
19 Administrative Law Judge or the Commission.

20 IT IS FURTHER ORDERED that the Presiding Administrative Law Judge may rescind, alter,  
21 amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by  
22 ruling at hearing.


