BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. In Commission Decision No. 59005 (February 24, 1995), the Commission granted Craig R. Williamson dba WillCall Payphone Services ("WillCall" or "Applicant") a Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") service in Arizona.

2. On January 12, 2011, WillCall filed an application with the Commission requesting approval to cancel its CC&N to provide COPT service in Arizona.

3. On March 1, 2011, the Commission's Utilities Division ("Staff") filed a Memorandum in this docket, in which Staff recommends approval of the application.

4. Staff stated in the Memorandum that WillCall indicated to Staff that WillCall no longer provides service in Arizona, and that WillCall waives its right to a hearing in this matter.

5. Staff's Compliance Section shows no compliance delinquencies.

6. Staff's Consumer Services Section shows no complaints, inquiries, or opinions filed against WillCall.

- 1 7. Staff recommends approval of the application.
- 2 8. Staff's recommendation for approval of WillCall's application for cancellation of its
- 3 CC&N is reasonable and should be adopted.

CONCLUSIONS OF LAW

- 5 1. Craig R. Williamson dba WillCall Payphone Services is a public service corporation
- 6 within the meaning of Article XV of the Arizona Constitution and A.R.S. §§ 40-281 and 40-282.
- 7 2. The Commission has jurisdiction over Craig R. Williamson dba WillCall Payphone
- 8 Services and the subject matter of the application.
- 9 3. The cancellation of Craig R. Williamson dba WillCall Payphone Services' CC&N to
- 10 provide customer owned pay telephone services in Arizona is in the public interest.
- 11 4. Craig R. Williamson dba WillCall Payphone Services waived its right to notice and a
- 12 hearing in this matter.
- 13 5. Staff's recommendation is reasonable and should be adopted.



ORDER


