PROCEDURAL ORDER

**BY THE COMMISSION:**

By Procedural Order dated February 14, 2011, oral argument was set in this matter for April 20, 2011.

On April 12, 2011, the Arizona Corporation Commission's ("Commission") Utilities Division ("Staff"), joined by Qwest Corporation ("Qwest"), Level 3 Communications, LLC ("Level 3") and Pac-West Telecomm, Inc. ("Pac-West") filed a Joint Motion to Continue Hearing.


The joint movants seek a continuance in this matter in order to give Qwest, Pac-West Telecomm and Level 3, an opportunity to engage in settlement discussions under the provisions of Section 41 of the Settlement Agreement that was accepted in Decision No. 72232 which approved the Qwest/CenturyLink, Inc. merger. The parties state that they have been engaged in settlement

1 discussions and that impasse has not been reached such that possible settlement is possible. They  
2 request that oral argument be continued for approximately 45 days.

3 IT IS THEREFORE ORDERED that the **April 20, 2011 Procedural Conference for the**  
4 **purpose of oral argument is continued until June 17, 2011, at 10:00 a.m.,**<sup>1</sup> or as soon thereafter as  
5 is practical, at the Commission's **Tucson office, Room 222**, 400 West Congress St., Tucson, Arizona  
6 85701.

7 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
8 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


