
1. BIA and Mohave are continuing their efforts to settle this matter, and will file a report to the Commission providing a status report regarding those efforts, or an outline of an agreed proposed settlement if such discussions are completed, on or before Friday, May 20, 2011.
2. In the event that the parties cannot resolve this matter, the parties will pre-file any new direct testimony on or before Friday, June 8, 2011.
3. The parties will file any new rebuttal testimony on or before Tuesday, June 28, 2011.
4. The parties will file prehearing briefs on or before Wednesday, July 13, 2011.
