PROCEDURAL ORDER

BY THE COMMISSION:

On April 16, 2010, Bonita Creek Land and Homeowners Association ("Association") filed with the Arizona Corporation Commission ("Commission") an application to transfer its assets and Certificate of Convenience and Necessity ("CC&N") to the newly named Bonita Creek Property and Preservation Association ("BCPPA").

On May 27, 2010, the Association docketed an affidavit of publication showing that notice of the application had been published in the *Payson Roundup*, a weekly newspaper in the Association's service area.

On July 23, 2010, the Commission's Utility Division ("Staff") filed a Letter of Insufficiency and submitted the first set of data requests to the Association.

On September 15, 2010 and September 23, 2010, Vickie Goulette and Clay Moser, respectively, filed Motions to Intervene in this matter.

On October 20, 2010, by Procedural Order, Vickie Goulette and Clay Moser were granted intervention in this matter. Additionally, Staff was ordered to docket copies of all data requests sent to the Association, and all responses from the Association, within 10 days of generating or receiving such documents.

On October 26, 2010, Staff filed Notice of Filing Data Requests.


On March 31, 2011, Staff filed a Motion to Administratively Close Docket ("Motion").

1 Staff's Motion states that the Association has decided that it does not want, nor does it intend to
2 change its name, and therefore a transfer of assets and the CC&N is unnecessary.

3 Accordingly, it is reasonable and appropriate to administratively close this docket.

4 IT IS THEREFORE ORDERED that **Docket No. W-02195B-10-0146** is hereby
5 **administratively closed.**


