PROCEDURAL ORDER

BY THE COMMISSION:

On November 22, 2010, Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission") an application for authorization for the purchase of generating assets from Southern California Edison ("SCE") and for an accounting order. The application seeks authority for APS to acquire SCE's interest in the Four Corners Power Plant.

On April 12, 2011, the Southwestern Power Group II, L.L.C. and Bowie Power Station, L.L.C. ("SWPG/Bowie") filed a joint application to intervene.

No objections have been filed to SWPG/Bowie's request for intervention.

IT IS THEREFORE ORDERED that SWPG/Bowie are hereby granted intervention.
