Dear Mr. Bozzo:

On February 9, 2011, Integra Telecom Holdings, Inc. (Integra) made a compliance filing pursuant to Decision No. 72018, dated December 10, 2010, in which the Commission ordered Integra to file "a revised Integra tariff that maintains the terms and conditions currently offered by Sharenet for the customer base being transferred from Sharenet." At that time, the parties to this transaction had not received approval from the Federal Communications Commission (FCC) and were unable to close the transaction as planned. In order to meet the compliance requirement of Decision No. 72018, I enclosed a proposed Title Page and Check Sheet for the Sharenet tariff. The Title Page indicated that Integra would concur in and adopt the Sharenet tariff as it may apply to the Sharenet customers that will be transferred to Integra, but it did not show a specific Effective Date.

The parties received approval from the FCC and have closed the transaction on April 15, 2011. Integra and Sharenet have notified the Sharenet customers in accordance with the draft notice and notice proposal as stated in their October 19, 2010 Application to the Commission. Therefore, I have enclosed an updated Title Page and Check Sheet which showing an Effective Date of May 16, 2011, 30 days after notice was provided to the Sharenet customers in accordance with FCC rules.

Integra is again providing the original and 13 copies of this filing to the Docket Control Center and one copy for the Compliance Section. Please contact the undersigned with questions or concerns.
