16 **BY THE COMMISSION:**

17 Having considered the entire record herein and being fully advised in the premises, the  
18 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

19 FINDINGS OF FACT

20 1. On November 10, 2003, the Commission issued Decision No. 66520 which granted  
21 Telliss, LLC ("Telliss" or "Company") a Certificate of Convenience and Necessity ("CC&N") to  
22 provide resold interexchange telecommunications services in Arizona.

23 2. On May 8, 2009, Telliss filed with the Commission an application stating that  
24 TELLISS ceased operations on December 31, 2007, and requesting that its CC&N be cancelled.

25 3. On April 7, 2011, the Commission's Utilities Division ("Staff") filed a Staff Report in  
26 this matter recommending approval of Telliss' application to cancel its CC&N. According to the  
27 Staff Report, Staff has been unable to contact Telliss, however, Staff's investigation of Company  
28 filings indicates that the Company is not serving customers in Arizona.

4. According to the Commission's Consumer Services Section, zero complaints,  
inquiries, or opinions were filed against Telliss for the period January 1, 2008, through March 1,  
2011.
