RE: **NOTICE OF CLARIFICATION – STAFF’S CLARIFICATION OF THE FILED STAFF REPORT FOR GRANITE MOUNTAIN WATER COMPANY, INC.’S APPLICATION FOR AUTHORITY TO INCUR LONG-TERM DEBT (DOCKET NO. W-02467A-10-0483)**

The Utilities Division (“Staff”) of the Arizona Corporation Commission provides this clarification regarding compliance items recommended by Staff in its Staff Report docketed on April 6, 2011, for the financing application of Granite Mountain Water Company, Inc. Staff’s clarification modifies the filing dates recommended in the Staff Report for two compliance items: the Arizona Department of Environmental Quality Approval to Construct and Approval of Construction. The purpose of the clarification is to make the recommended due dates for those filings consistent with the dates in the Order approved by the Commission at Open Meeting on April 27, 2011, which extended the time deadlines contained in Decision No. 71869, Docket Nos. W-02467A-09-0333 and W-02467A-09-0334.

Therefore, Staff asks that the April 6, 2011, Staff Report be modified as follows:

Executive Summary, page 2, last paragraph:

DELETE “within 90 days of this decision” and **INSERT** “by September 1, 2011”

DELETE “within 180 days of obtaining the ATC” and **INSERT** “by September 1, 2012”

Page 3, last paragraph:

DELETE “within 90 days of this decision” and **INSERT** “by September 1, 2011”

DELETE “within 180 days of obtaining the ATC” and **INSERT** “by September 1, 2012”
