On August 31, 1998, Staff opened a generic docket in the above matter.

In Decision No. 61289, dated December 14, 1998, the Commission ordered "that AAC. R14-2-212, R14-2-312, R14-2-411, R14-2- 510, R14-2-610, R14-2-902, R14-2-1002, R14-2-1103, and R14-2-1603, as set forth in Appendix A; the Economic, Small Business, and Consumer Impact Statement as set forth in Appendix B; and the Concise Explanatory Statement, as set forth in Appendix C are hereby adopted" and "that the Arizona Corporation Commission's Utilities Division shall immediately forward the adopted amended Rules, A.A.C. R14-2-212, R14-2-312, R14-2-411, R14-2-510, R14-2-610, R14-2-902, R14-2-1002, R14-2-1103, and R14-2-1603, to the Secretary of State."

The sections referenced above have been incorporated into the Commission's rules. Therefore, Staff recommends that this Rulemaking docket be closed.
