PROCEDURAL ORDER
(Administratively Closes Docket)

BY THE COMMISSION:

On October 30, 2009, the Arizona Corporation Commission (“Commission”) issued Decision No. 71316, approving a surcredit of \$0.08 per therm for UNS Gas, Inc. (“UNS Gas” or “Company”) The surcredit became effective on November 1, 2009, and was scheduled to continue for twelve months, or until UNS Gas’ purchased gas adjustor (“PGA”) bank balance reached zero, whichever occurred first.

On May 10, 2010, UNS Gas filed a Motion for Extension of Time or, in the Alternative, Motion to Amend Decision No. 71316. By its Motion, the Company requested that the surcredit be continued until July 1, 2010, in order to avoid customer confusion that would result from a PGA credit reduction in the same timeframe as implementation of a base rate increase authorized by Decision No. 71623 (April 14, 2010).

On June 8, 2010, a Recommended Opinion and Order was issued by the Commission’s Hearing Division which recommended amending Decision No. 71316, as requested by UNS Gas.

On June 14, 2010, UNS Gas filed a Request to Withdraw Motion, stating that the Company’s PGA bank balance would not reach zero until sometime after July 1, 2010 and, therefore, it was no longer necessary to amend Decision No. 71613.
