



Pursuant to A.A.C. R14-3-106(K) Southwestern Power Group II, L.L.C. and Bowie Power Station, L.L.C. ("SWPG/Bowie") hereby move for leave to withdraw as an intervenor in the above-captioned and above-docketed proceeding. The circumstances occasioning SWPG/Bowie's request are as follows.

SWPG is a member of the Arizona Competitive Power Alliance ("Alliance"), which is also an intervenor in the instant proceeding. At present, the Alliance's Executive Director is also its attorney of record in this matter. Recently, the Alliance inquired of SWPG/Bowie as to whether they would allow their attorney of record to be substituted as the Alliance's attorney of record, in order that the Alliance's Executive Director would be in a position to testify on behalf of the Alliance in the forthcoming evidentiary hearings.

SWPG/Bowie have considered the aforesaid request of the Alliance, and they are willing to accommodate the same. In that regard, they have also concluded that SWPG/Bowie's continued participation in this matter would no longer be necessary in this particular instance, inasmuch as the Alliance's participation will address matters of interests to SWPG/Bowie.
