
JOINT STATUS REPORT

In a procedural order dated May 5, 2011, the administrative law judge ordered Arizona Water Company ("AWC") and Cornman Tweedy 560, LLC ("Cornman Tweedy") to file by May 31, 2011, a status report regarding their settlement discussions. The procedural order further directed that if a full settlement of the issues is not completed and filed by that date, "the parties shall discuss informally a procedural schedule for discovery, filing of testimony, and hearing, and submit proposed dates in the May 31, 2011 status report so that the matter may be scheduled for hearing at the earliest possible date after the filing." While AWC and Cornman Tweedy have not reached a settlement at this time, they believe in good faith that a settlement may still be achievable and is worth further pursuit. The parties met in Phoenix on March 21, 2011 to discuss settlement, and since that date they have continued to exchange information through telephone calls and e-mails. Additional information was provided by Cornman Tweedy to AWC as recently as May 24, 2011. Therefore, the parties request an additional 30 days to make a final effort to reach settlement. If a settlement is reached, the parties will so notify the Commission in a filing. However, if the parties cannot reach a full settlement within the additional time, then they will jointly file a proposed procedural schedule for discovery, filing of testimony and a hearing date on July 8, 2011.


