PROCEDURAL ORDER

BY THE COMMISSION:

On December 17, 2010, Baca Float Water Company, Inc.'s, Sewer Division ("Baca Float") filed with the Commission an application for a permanent increase in its wastewater rates.

On April 4, 2011, the Commission's Utilities Division ("Staff") filed its Staff Report in this matter.

On May 3, 2011, Baca Float filed its Response to the Staff Report, providing additional information that Baca Float would like to have taken into consideration in the establishment of its rates.
