BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On July 17, 1996, the Commission issued Decision No. 59749, granting Arnan LLC ("Arnan" or "Company")¹ a Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") services in Arizona.

2. On October 8, 2010, Arnan filed with the Commission a letter requesting to cancel its CC&N to provide COPT services in Arizona.

3. On March 28, 2011, the Arnan filed a completed application stating that the Company no longer provides, or never did provide, COPT service in the State of Arizona and requested cancellation of its CC&N ("Application"). The Application further indicates that the Company waived its right to notice and a hearing to cancel the CC&N.

4. On April 11, 2011, the Commission's Utilities Division ("Staff") filed a Staff Report recommending approval of Arnan's Application to cancel its CC&N. The Staff Report further


ORDER

IT IS THEREFORE ORDERED that the application of Arnan LLC for cancellation of its Certificate of Convenience and Necessity to provide customer owned pay telephone services in Arizona is hereby approved.

IT IS FURTHER ORDERED that upon cancellation of its CC&N, Arnan LLC will not be authorized to provide COPT telecommunications services in the state of Arizona and, therefore, will not be subject to any of the requirements of Decision No. 59749.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
