PROCEDURAL ORDER

BY THE COMMISSION:

On December 22, 2000, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against the Chamber Group, Inc. a.k.a. Chamber Financial Group or Chamber Financial ("CGI") Joseph L. Hiland, Tyson J. Hiland and Travis D. Hiland (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of certificates of deposit, viatical settlements, tax lien programs and investment contracts. As a result of the T.O., the Respondents were immediately ordered to cease and desist from violating the Act.

The Respondents were all duly served with copies of the Notice.

On January 12, 2001, Respondents CGI, and Messrs. Hiland filed a request for hearing.

1 Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the
2 T.O. and the Notice and the presentation of evidence.

3 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on January 30,
4 2001, at 1:30 p.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


