PROCEDURAL ORDER

18 **BY THE COMMISSION:**

19 At the conclusion of the hearing in the above-captioned proceeding, it was agreed that the  
20 record would be held open until on or about June 4, 2001, for the Respondents to file Notice of Filing  
21 Evidence of Redemption ("Notice") which would be marked as Exhibit R-3 and admitted into  
22 evidence if there were no objections filed by the Securities Division ("Division") of the Arizona  
23 Corporation Commission ("Commission") in the above-captioned proceeding.

24 On June 4, 2001, as indicated at the conclusion of the proceeding, Respondents filed the  
25 Notice.

26 On June 11, 2001, the Division filed a Motion to Preclude Admission of Respondents Exhibit  
27 R-3 ("Motion").

28 On June 28, 2001, the Respondents filed a Response to the Division's Motion.

1 After considering the arguments raised by the Division and the Respondents with respect to  
2 the admission of Exhibit R-3, it is determined that Exhibit R-3 shall remain and be an exhibit and part  
3 of the record of the proceeding.

4 IT IS THEREFORE ORDERED that the Motion filed by the Securities Division to preclude  
5 the admission of Respondent's Exhibit R-3 be, and is hereby, denied.

6 IT IS FURTHER ORDERED that Exhibit R-3 is admitted into evidence.


