PROCEDURAL ORDER

BY THE COMMISSION:

On February 22, 2011, Orange Grove Water Company, Inc. (“OGWC” or “Company”) filed with the Arizona Corporation Commission (“Commission”) an Application for Approval of Financing in Docket No. W-02237A-11-0084 (“Financing Application”).

On April 27, 2011, OGWC filed with the Commission an Application for Approval of a Rate Increase in Docket No. W-02237A-11-0180 (“Rate Application”).

On May 4, 2011, OGWC filed notice that it mailed a notice of its requested rate increase to each of its customers on May 2, 2011.

On May 26, 2011, the Commission’s Utilities Division (“Staff”) filed a Letter of Sufficiency indicating that the Rate Application met the sufficiency requirements as outlined in Arizona Administrative Code R14-2-103, and classifying OGWC as a Class D utility.


On June 10, 2011, Staff filed Motions to Consolidate in the Financing Application docket and the Rate Application docket (“Motions”). In the Motions, Staff stated that the matters are substantially related and most appropriately processed in a consolidated docket.

Good cause is shown and accordingly, Staff’s Motions should be granted.


