
**STIPULATION REGARDING
DIRECT TESTIMONY OF STEVEN
SORIANO**

9 Intervenor PebbleCreek Properties Limited Partnership ("PebbleCreek") and the
10 undersigned parties and intervenors waive any objection to the written testimony of
11 Steven Soriano, filed June 7, 2011, and stipulate that Mr. Soriano's written testimony
12 should be admitted into evidence. Neither PebbleCreek nor its witness, Mr. Soriano, take
13 any position on the issue of when funds collected via the HUF are considered CIAC or a
14 deduction from rate base. PebbleCreek's position relates solely to the establishment of an
15 Active Adult Community tariff in the event that a HUF is adopted. With that
16 understanding, the undersigned parties and intervenors waive Mr. Soriano's presence
17 during the hearing of this matter, and waive their right to cross examine him during the
18 hearing.






