PROCEDURAL ORDER

BY THE COMMISSION:

On January 4, 2011, Arivaca Townsite Cooperative Water Company ("Arivaca") filed with the Commission an application for a permanent rate increase ("Application").

On April 29, 2011, the Commission's Utilities Division ("Staff") issued its Sufficiency Letter indicating that Arivaca's Application was sufficient under the Arizona Administrative Code, and also stating that the Staff Report in this matter would be docketed on or about June 28, 2011.

On June 23, 2011, Staff filed a Motion for Extension of Time to File Staff Report ("Motion"). Staff noted that Arivaca responded 15 days late to some of Staff's data requests. Accordingly, Staff requests a corresponding extension of time to file its Staff Report. Staff also requested a corresponding extension of time for the Commission to issue its final order in this matter. Staff noted that Arivaca does not oppose the Motion.

IT IS THEREFORE ORDERED that Staff's Motion is granted and Staff shall file its **Staff Report no later than July 13, 2011.**

IT IS FURTHER ORDERED that the **deadline** for the issuance of the Commission's final order in this matter shall be extended to on or about **September 13, 2011.**
