FUND REQUEST REGARDING PRE-  
HEARING CONFERENCE

20 Western Resource Advocates ("WRA") and Environmental Defense Fund  
21 ("EDF") file this request to inform the Administrative Law Judge that their counsel will  
22 be unable to attend the pre-hearing conference scheduled for June 30, 2011 at 1:30 PM.  
23 Counsel has a hearing in Maricopa County Superior Court at 2:00 PM on the same day  
24 and, therefore, will be unable to attend the pre-hearing conference. Nevertheless, WRA  
25 and EDF witnesses at this time have no scheduling constraints with regard to the dates  
currently scheduled for hearing in this matter. However, they request that the date and

1 time of their testimony be fixed at the pre-hearing conference so they know in advance  
2 when they are generally scheduled to appear and testify.

3 Additionally, WRA and EDF want to inform the Administrative Law Judge that  
4 they will have minimal, if any, cross examination for the other witnesses who have filed  
5 testimony in this matter.

6 Finally, to the extent necessary, WRA and EDF request that the Administrative  
7 Law Judge allow representatives from WRA (Dr. David Berry) and EDF (Pamela  
8 Campos and/or Bruce Polkowsky) to participate in person or by telephone for the purpose  
9 of establishing an appropriate schedule for their testimony.
