PROCEDURAL ORDER

BY THE COMMISSION:

On July 29, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") against Premiere Financial Group, Inc., Heritage Properties, Inc., Estate Guardian Services, Inc. and Mr. John H. Lawson (collectively the "Respondents") in which the Division alleged multiple violations of the Securities Act ("Act") in connection with the offer and sale of securities in the form of notes or other evidences of indebtedness.

The Respondents were duly served with copies of the Notice.

On August 11, 1999, counsel for the Respondents filed a timely request for hearing.

Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the Notice and the presentation of evidence.


