17 On November 30, 1998, Sierra Southwest Electric Power Cooperative Services, Inc.  
18 ("SSWEPCO") filed an application for a Certificate of Convenience and Necessity to Provide  
19 Competitive Retail Electric Services as an Electric Provider Pursuant to A.A.C. R14-2-1601 *et seq.*

20 On April 15, 1999, Cyprus Climax Metals Company ("Cyprus"), ASARCO Incorporated  
21 ("ASARCO") and Enron Corp. ("Enron") filed an Application for Leave to Intervene.

22 SSWEPCO has filed no opposition to Cyprus, ASARCO and Enron being granted  
23 intervention.


