**COMPLAINANTS' QUARTERLY
STATUS UPDATE**

17 Complainants Roger and Darlene Chantel, by and through undersigned counsel and
18 pursuant to the Arizona Corporation Commission's December 22, 2009 Procedural Order,
19 hereby file the following quarterly status update to the Commission regarding the status of
20 Complainants' Superior Court action against Respondent Mohave Electric Cooperative, Inc.
21 (Superior Court of Arizona in and for Mohave County, Case No. CV2009-02574).¹

24 ¹ On June 17, 2011, the Commission granted counsel for the Complainants, Jonathan A.
25 Dessauls, Douglas C. Wigley, and the Dessauls Law Group's ("Counsel") Application to
26 Withdraw. The filing of this Quarterly Status Update on behalf of the Complainants is being
done as a professional courtesy due and is the final action taken on behalf of the Complainants
in this matter.

1 Complainants' case in Superior Court is still pending and the parties are still conducting
2 discovery. On May 23, 2011, Counsel for Complainants, Plaintiffs in the Superior Court action,
3 filed a Motion to Withdraw as Counsel of Record in the Superior Court action. Complainants
4 opposed Counsel's withdrawal and a hearing on the matter was held on June 29, 2011, where
5 the Superior Court granted Counsel's Motion to Withdraw. As such, Counsel is no longer
6 counsel of record in either this proceeding or the Superior Court case.

7 Respondent, Defendant in the Superior Court case, has filed a motion for summary
8 judgment on Plaintiffs' claims in the Superior Court. The Superior Court has not ruled on the
9 motion for summary judgment at this time and it is believed that responsive pleadings are still
10 pending. In addition to the pending motion for summary judgment, the parties in the Superior
11 Court action have a scheduling order in place and the Court has set a scheduling conference for
12 September 28, 2011, for the purpose of setting a trial date. Going forward Complainants, or
13 their new counsel, will be responsible for filing this quarterly status update.
