On March 30, 2011, Mohave Electric Cooperative, Inc. ("Mohave" or "Cooperative") filed its application for a determination by the Arizona Corporation Commission ("Commission") of the fair value of its property for ratemaking purposes, to fix a just and reasonable return thereon and to approve rates designed to develop such return.

On June 27, 2011, Commission Staff issued its Letter of Sufficiency and filed its Proposed Schedule for Filing Dates.
