PROCEDURAL ORDER

**BY THE COMMISSION:**

On June 1, 2011, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application to determine the fair value of the utility property of the Company for ratemaking purposes, to fix a just and reasonable rate of return thereon, and to approve rate schedules designed to develop such return.

On July 1, 2011, Commission's Utilities Division ("Staff") filed its Letter of Sufficiency indicating that APS satisfied the requirements of Arizona Administrative Code ("A.A.C.") R14-2-103 and classifying the Company as a Class A utility.

Accordingly, a procedural conference should be held to discuss hearing dates and other procedural issues. The parties should come to the procedural conference prepared to discuss their proposed schedule(s).

IT IS THEREFORE ORDERED that a **procedural conference** shall commence on **July 18, 2011, at 10:00 a.m.**, or as soon as possible thereafter, at the Commission's offices, 1200 West Washington St., Hearing Room No. 1, Phoenix, Arizona.
