

23 **1. On March 2, 2011 Arizona-American Water Company (Arizona-American”)**
24 **filed an application with the Commission by which Arizona-American’s parent company,**
25 **American Water Works Company, Inc. will sell all of the issued and outstanding shares of**
26 **Arizona-American’s common stock to EPCOR Water (USA) Inc. (the “Transaction”).**

27 **2. Arizona-American has requested that the Commission either order that the**
28 **Affiliated Interests Rules do not apply to the Transaction, grant a waiver, or approve the**
29 **Transaction without a hearing.**


