JOINT PROPOSAL ON PROCEDURAL SCHEDULE

In a procedural order dated June 15, 2011, the administrative law judge ("ALJ") ordered Arizona Water Company ("AWC") and Cornman Tweedy 560, LLC ("Cornman Tweedy") to file by June 30, 2011, notification of settlement, if applicable. If a full settlement of the issues was not filed by the specified date, the parties were ordered to jointly file by July 8, 2011, a proposed procedural schedule for discovery, the filing of testimony and a hearing date in this docket. The parties have not reached a settlement in this case. Therefore, pursuant to the procedural order, the parties propose the following procedural schedule:


