PROCEDURAL ORDER

**BY THE COMMISSION:**

On November 12, 2010, Southwest Gas Corporation ("SWG") filed with the Arizona Corporation Commission ("Commission") an application for an increase in rates for service provided in Arizona.

By Procedural Order issued January 7, 2011, a hearing was scheduled and other procedural dates were established.

On July 12, 2011, SWG filed a Motion requesting an extension of time for filing rebuttal testimony, from July 15, 2011 to July 22, 2011, to enable the parties to continue settlement discussions. SWG represents that no other party opposes its request, with the exception of Cynthia Zwick who was unavailable prior to filing of the Motion.

**IT IS THEREFORE ORDERED that SWG's Motion is hereby granted. SWG shall file its rebuttal testimony by July 22, 2011.**

**IT IS FURTHER ORDERED that in all other respects, the current procedural schedule shall remain in effect.**

IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules of the Arizona Supreme Court and A.R.S. § 40-243 with respect to the practice of law and admission *pro hac vice*.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance

1 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the  
2 Rules of the Arizona Supreme Court). Representation before the Commission includes appearances  
3 at all hearings and procedural conferences, as well as all Open Meetings for which the matter is  
4 scheduled for discussion, unless counsel has previously been granted permission to withdraw by the  
5 Administrative Law Judge or the Commission.

6 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized  
7 Communications) applies to this proceeding and shall remain in effect until the Commission's  
8 Decision in this matter is final and non-appealable.

9 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
10 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
11 hearing.


