**ANTHEM COMMUNITY COUNCIL'S RESPONSE TO MOTION TO CONTINUE DEADLINE FOR FILING OF DIRECT TESTIMONY**

The Anthem Community Council ("Anthem") hereby responds to the July 12, 2011, "Stipulated Motion to Continue Deadline for Filing Direct Testimony" filed by the Corte Bella Country Club Association, Inc. ("Corte Bella"). The Motion asks for a two-week extension for parties to file direct testimony and exhibits.


On July 5, 2011, the undersigned was contacted by counsel for Corte Bella to ask for Anthem's agreement to extend the deadline for the filing of direct testimony by two weeks. Counsel indicated that Arizona-American Water Company ("AAWC"), the Arizona Corporation Commission's staff ("Staff"), and the Residential Utility Consumer Office

1 ("RUCO") had already been contacted and did not oppose the request. Anthem also agreed  
2 to the two-week extension for the filing of direct testimony.

3 On July 13, 2011, AAWC's counsel filed a "Response to Motion to Continue  
4 Deadline for Filing Direct Testimony" clarifying that AAWC does not oppose Corte  
5 Bella's request for a two-week extension "provided that all other dates, including the  
6 scheduled hearing dates, are also extended for at least the same amount of time." Anthem  
7 wishes to similarly clarify its position and also requests that, in order to provide a  
8 reasonable amount of time for Anthem to fully and fairly respond to testimony and filings,  
9 all deadlines and hearing dates, including the deadline for the filing of direct testimony, be  
10 extended by two weeks in each case.
