PROCEDURAL ORDER

BY THE COMMISSION:

On March 25, 2011, a Procedural Order was issued consolidating the above-captioned dockets and setting the matter for hearing and directing Staff to file its Staff Report or Direct Testimony by July 13, 2011.

1 On July 13, 2011, Staff filed a Request for Extension of Time (“Extension Request”) for the
2 filing of the Direct Testimony of Staff witness Jeff Michlik until July 27, 2011. Staff contacted the
3 Company regarding the extension and it did not object to the extension. Staff noted that the Direct
4 Testimony of Staff Engineering witness, Katrin Stukov would be filed on time and it was, in fact,
5 filed on July 13, 2011.

6 No objections existing, Staff’s Extension should be granted.

7 Because of the two week extension, it is reasonable to extend the remaining filing deadlines.

8 **IT IS THEREFORE ORDERED that Staff’s Request for Extension of Time for filing the**
9 **Direct Testimony of Jeff Michlik from July 13, 2011, to July 27, 2011, is granted.**

10 **IT IS FURTHER ORDERED that the Companies’ Rebuttal Testimony shall now be due on**
11 **August 10, 2011.**

12 **IT IS FURTHER ORDERED that any Surrebuttal Testimony shall now be due on August**
13 **22, 2011.**

14 **IT IS FURTHER ORDERED that any Rejoinder Testimony is still due on August 31, 2011.**

15 **IT IS FURTHER ORDERED that all other deadlines and requirements relating to the**
16 **timing and form of filings stated in the March 25, 2011, Procedural Order are still in effect.**


17 **IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized**
18 **Communications) applies to this proceeding as the matter is now set for public hearing, and shall**
19 **remain in effect until the Commission’s Decision in this matter is final and non-appealable.**

20 **IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules**
21 **of the Arizona Supreme Court and A.R.S. §40-243 with respect to the practice of law and admission**
22 **pro had vice.**

23 **IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance**
24 **with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the**
25 **Rules of the Arizona Supreme Court). Representation before the Commission includes the obligation**
26 **to appear at all hearings and procedural conferences, as well as all Open Meetings for which the**
27 **matter is scheduled for discussion, unless counsel has previously been granted permission to**
28 **withdraw by the Administrative Law Judge.**

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
2 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
