**REQUEST FOR EXTENSION OF TIME**

On September 30, 2010, Arizona Public Service Company ("APS" or "Company") filed an application seeking Arizona Corporation Commission ("Commission") approval for a proposed Electric Vehicle Readiness Demonstration Project ("ev-READY Project"). On June 29, 2011, Commission Staff ("Staff") filed a Staff Report and Proposed Order in response to the Company's proposal, and on July 7, 2011, Staff filed a revised Proposed Order in this matter. The Residential Consumer Utility Office ("RUCO") filed comments in response to Staff's recommendations on July 8, 2011.

It is clear from the Staff Report and Proposed Orders that Staff has filed, as well as from RUCO's comments, that there are differing views on the role that APS should have regarding electric vehicle ("EV") recharging, monitoring the potential impact of EVs on the utility distribution system, and EVs as a prospective distributed energy resource. As a result, APS is requesting that before the Commission makes its determination in this matter, the Company be provided additional time to meet with Staff and stakeholders to develop an alternative proposal. Initial discussions are already underway, and APS believes that it will be able to file an alternative proposal within 20 days.
