The 19th Procedural Order forbids this, and Mrs. Bosworth must therefore mount a separate defense. She needs adequate time to do so.


Should the hearing be continued, the Sargents renew their request that a settlement judge be appointed. The Sargents also note that the parties have blocked out the next two weeks for the
