BY THE COMMISSION:

On June 1, 2011, Arizona Public Service Company filed with the Arizona Corporation Commission ("Commission") an application to determine the fair value of the utility property of the Company for ratemaking purposes, to fix a just and reasonable rate of return thereon, and to approve rate schedules designed to develop such return.

On July 29, 2011, by Procedural Order, the above-captioned matter was set for hearing, and other procedural dates were established, including a date for a pre-hearing conference. The date set for the pre-hearing conference did not include a time, and accordingly, this Procedural Order will set the pre-hearing conference to commence at 10:00 a.m.

IT IS THEREFORE ORDERED that the pre-hearing conference scheduled for **January 13, 2012, shall commence at 10:00 a.m.**, at the Commission's offices, 1200 West Washington Street, Hearing Room No. 1, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that all other provisions of the July 29, 2011, Procedural Order remain in effect.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized Communications) applies to this proceeding and shall remain in effect until the Commission's Decision in this matter is final and non-appealable.

1 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
2 pursuant to Rule 6(a) or (e) of the Rules of Civil Procedure.

3 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
4 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
5 hearing.
