PROCEDURAL ORDER

**BY THE COMMISSION:**

By Procedural Order dated June 2, 2011, a procedural schedule was set in this matter.

On July 6, 2011, the Residential Utility Consumer Office ("RUCO") filed a Motion to Clarify Procedural Order. RUCO noted that the June 2, 2011 Procedural Order contains conflicting information concerning the deadline for filing testimony in the event there is a settlement reached in the matter by December 9, 2011.

RUCO is correct in its observation that the intent of the Procedural Order was to require testimony in support of, or in opposition to, the potential settlement agreement to be filed no later than January 6, 2012.<sup>1</sup> The ordering paragraph on Page 4, line 14 should be corrected to reflect this intent.<sup>2</sup>

**IT IS THEREFORE ORDERED that the June 2, 2011 Procedural Order is corrected to reflect that in the event a settlement is reached, testimony in support of, or in opposition to, the settlement shall be filed by January 6, 2012.**

**IT IS FURTHER ORDERED that all other provisions of the June 2, 2011, Procedural Order remain unchanged.**




