NOTIFICATION OF
INTERVENTION

BY THE COMMISSION:

On July 22, 2011, Freeport-McMoRan Copper & Gold, Inc. ("Freeport-McMoRan") and Arizonans for Electric Choice and Competition ("AECC") filed an Application to Intervene in the above captioned matter.

Freeport McMoRan is a large industrial user of electric services from Tucson Electric Power ("TEP"). AECC is a coalition of energy consumers which has members who are customers of TEP. Each states that it will be directly and substantially affected by TEP's 2011-2012 Energy Efficiency Implementation Plan for which TEP is seeking Commission approval in this proceeding.

The participation of Freeport McMoRan and AECC will not broaden the issues nor unduly delay the proceeding. No party objected to their intervention

IT IS THEREFORE ORDERED that Freeport McMoRan's and AECC's Application to Intervene in this matter is granted.
